

## Guide to the Special Benefit(JPY100,000/household)

for Supporting households who are exempt from the Resident's Tax, etc.

Application is required.

- A new benefit (JPY100,000/household) is being provided to support households who are exempt from the Resident's Tax (per capita) or households whose incomes decreased suddenly on or after January 1, 2021 due to the outbreak of COVID-19.
- Application is required to receive this benefit.

### Payment Amount

Flat rate of JPY 100,000 / household

### Payment Period

It takes approximately two weeks after your local municipality receive the Confirmation Form (Application Form).

### Eligible Recipients and Necessity of Application

#### Households eligible for payment (Either of the following apply)

Households who **are exempt from the Resident's Tax (per capita)** for FY 2021

Households whose incomes decreased suddenly on or after January 1, 2021, and become **equivalent to levels exempt from Resident's Tax**. (Households with sudden financial situation change)

The Confirmation Form will be delivered via post from your local municipality.  
(Sending back is required)  
※ In some cases application may be required.  
The Confirmation Form will be delivered via post from your local municipality where your residency is registered (place of residence) by December 10, 2021.

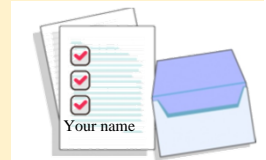
# Payment Procedures

I Households who **are exempt from the Resident's Tax (per capita)** for FY 2021

**ALL members of a household have lived at the current address since January 1, 2021**

- Households eligible for payment will receive the Confirmation Form with the details of your benefits and confirmation items from the local municipality.
- After you check it, please **send the Confirmation Form back** to your local municipality.  
【Confirmation items】

- ① The listed bank account for the transfer is correct
- ② NOT all members of the household are dependent relatives of those who are subject to residential taxation.



II Households whose incomes decreased suddenly due to the outbreak of COVID-19, and become **equivalent to levels exempt from Resident's Tax** ※. (Households with sudden financial situation change)

※ Equivalent to levels exempt from Resident's Tax means the estimated annual income of all household members (any monthly income since January, 2021 x 12) is less than or equal to the level of exemption from Resident's tax (per capita). (Because the applicable ceiling amount depends on the city, town, or village where your residency is registered, please consult with your local municipality)

(Example) Annual income standard of households who are equivalent to levels exempt from Resident's Tax (Tokoname)

A single household: JPY 930,000 or less; A single-mother household with one child: JPY 1,378,000 or less

- **Do need to apply** to receive this benefit.
- Please fill in the required information on the application form and submit it along with the required documents directly to the reception of your local municipality or by post.

**!** If you apply for this benefit payment although the sudden financial situation change is not caused by the outbreak of COVID-19, you may be charged with benefit fraud.



Please be careful of **bank transfer scams and personal information** fraud related to the Special Benefit for supporting households who are exempt from the Resident's Tax, etc.

Please contact your local municipality or the nearest police station or call the police consultation



phone line (#9110), if you receive a suspicious phone call or email to your home or workplace claiming to be from a prefecture or a municipality, or from a staff member of Cabinet Office.

- Tokoname City, Aichi Prefectural Government, and Cabinet Office will NEVER ask you to transfer processing fees via ATM (Automatic Teller Machine placed at banks or convenience stores)
- Tokoname City, Aichi Prefectural Government, and Cabinet Office will NEVER ask you to transfer processing fees via bank transfer for your benefit payment.
